Solutions Capital Management SIM Communication of new share capital

Solutions Capital Management SIM S.p.A. (the "Company" or "SCM SIM" or the "Issuer"), a company listed on Euronext Growth Milan of Borsa Italiana S.p.A. and in the open market "Quotation Board" segment of the Frankfurt Stock Exchange, announces the new composition of the share capital, following the filing of the attesting document with the Milan Companies' Register.

The paid-in capital increase transaction, offered under option, which concluded on 31 March 2023, envisaged the issue of a maximum of 300,936 shares, without nominal value, with the same characteristics as those in circulation, with regular entitlement, to be offered to shareholders at a unitary price of Euro 3.60 for a maximum equivalent value of Euro 1,083,369.60.

As part of this transaction, **228,024** shares have been subscribed, for a total equivalent value of Euro **820,886.40**, equal to 75.8% of the total amount approved.
